TERMS AND CONDITIONS

1. Storage starts November 1st ends May 1st
2. All boats must be out of the water by November 1st. Fees will be applied for boats still in the water on November 1st.
3. Forklift hours through November 1st are 8am to 6pm.
4. DO NOT fill gas tanks completely prior to being put in winter storage.
5. Boat re-launching is included if the boat is launched by May 15th AND you have contracted summer dockage at BBM. Non-summer dockage customers are subject to a re-launch fee.
6. Summer rack & launching will be prior to the summer season, dependent upon staffing and weather.
7. Summer rack & launch storage ends October 15th.
8. Winterization work orders must be paid within 10 days of completion.
9. There will be absolutely NO REFUNDS made under any conditions.
10. No work orders will be accepted past November 1st. Winterization is not guaranteed after the first freeze.
